I understand that my child will return to Gallery 37 Center for the Arts at approximately 12:30pm on the same day. I consent to my child participating in various activities as part of this field trip including bus transportation and the College Tour.

I understand that there is a risk my child will sustain injury or become ill during the activities described above. In the event that my child's emergency contact cannot be reached in an emergency, I give permission to After School Matters to secure proper medical treatment for my child in case of an illness or injury. I authorize the use or disclosure of my and my child's health information for purposes of securing health treatment. I agree that I may be required to pay all or most of the expenses incurred for such treatment.

I release and hold harmless After School Matters and its employees from all liability for any injury or illness my child may sustain, including the aggravation of any prior existing injuries, except where such injury or illness was caused by the willful misconduct or negligence of After School Matters. I fully assume all responsibility for injuries or illnesses my child may sustain while traveling to or from the program or while participating in program activities, except where such injury or illness was caused by the willful misconduct or negligence of After School Matters.
